FHA Late Fee Basis Change
March 23, 2016

Effective with FHA Case Number Assignments on and after March 14, 2016, the language regarding the late fee must indicate that the late fee percentage is based on the *overdue payment of principal and interest*. This requirement is based on revisions in the HUD Handbook (4000.1).

The late fee shows on Page 3 of the Loan Estimate and on Page 4 of the Closing Disclosure. You may want to verify with your document preparation vendor to ensure the appropriate verbiage is reflected on these documents, as well as any other required disclosure or document (e.g., the Note).
