### FEMA Disaster Declaration for Mississippi

May 25, 2017

FEMA has issued an updated presidential disaster declaration for Mississippi designating counties as eligible for public assistance. No locations for this FEMA disaster declaration are eligible for individual assistance at this time.

As stated in a recent Impac policy, re-inspections from the appraiser for properties located in these zip codes and counties that are eligible for *public* assistance will be required for appraisals issued prior to April 30, 2017, for iQM loans only.
